b. Review of City Street Banners, City Seal, City Fonts, etc

Discussion was led by Ms. Riggins after providing to the committee the mock ups of the city seal from the artist. Some modifications were offered by Ms. Bryant and Dr. Kron but the general consensus was the seal was liked. Specifically, the committee liked the roofline of Main Street on the seal, the use of the eagle and tractor as well as the wording and edge design. Changing the color of the two fields to a same color green (but less of a lime tone) changing the hillsides to a dark green and removing the clouds in the sky were agreed upon. There is also a black and white version for a stamp and other necessary usage where color is not an option. The seal is also simple enough to put on shirts and other materials. Ms. Riggins will get a mock up with the changes mentioned above and present it at the next meeting for approval.
